In Canada, regulations pertaining to electrical safety and product approval are under the jurisdiction of the Provinces and Territories. As exporter to Canada it is important for you to know that the QPS Certification Mark and Field Evaluation Label are accepted in all jurisdictions throughout the country

The purpose of this letter is to provide you with official evidence about the total acceptance of QPS by all the Regulatory Authorities across Canada, and to help you choose QPS as your Service Provider for product approval for the Canadian market.

At the federal level, QPS is accredited by the Standard Council of Canada (SCC) as [Certification body](#), and [Inspection Body](#) (i.e Field Evaluation Body).
